**The Technical Education, Vocational and Entrepreneurship  
Training (Establishment of Institutions and Constitution of  
Management Boards) (Amendment) Regulations, 2003**

IN EXERCISE of the powers contained in section *twenty-six* of the Technical Education, Vocational and Entrepreneurship Training Act, the following Regulations are hereby made:

1. These Regulations may be cited as the Technical Education, Vocational and Entrepreneurship Training (Establishment of Institutions and Constitution of Management Boards) (Amendment) Regulations, 2003 and shall be read as one with the Technical Education, Vocational Training (Establishment of Institutions and Constitution of Management Boards) Regulations, 1999, in these Regulations referred to as the principal Regulations.
