## **Concept Note and Tentative Programme**

The Meeting of the UN/INGO inter-agency South Asia Coordinating Group on Action against Violence against Children (SACG) and the SAIEVAC Regional Secretariat is being organized by the ILO (SACG Chair) on 19 June 2014 in Negombo, Sri Lanka. It is being held back-to-back with the 4th regional meeting of the National Coordinating and Action Groups against Violence against Children (NACGs), which is being organized by the SAIEVAC Regional Secretariat on 17 and 18 June. The meetings will bring together the SAIEVAC Regional Secretariat, NACGs chairs and co-chairs from the eight South Asian countries and representatives of SACG member agencies to review and reinforce action to end violence against children in South Asia.

The SACG works with SAIEVAC (SAARC Apex Body on Children), the National Action and Coordinating Groups against Children (NACG), children, young people and other stakeholders, including the Office of the Special Representative of the Secretary General on Violence against Children (SRSG VAC) to end all forms of violence against children in South Asia, through advocacy, institutional strengthening and technical support.

At their meeting on 19 June, the SACG members will review and update the status of their progress todate, in line with the four strategic areas identified as priorities for 2014:

- Strengthening and institutionalizing Child Participation,
- Strengthening and institutionalizing Civil Society Participation through the National Action and Coordinating Groups on Action against Violence against Children (NACG),
- Strengthening regional monitoring mechanisms, and
- SACG Advocacy and communication.

Meeting participants will be focal points of SACG Member and Associated agencies responsible for South Asia, which include: ILO (Chair), WVI (co-Chair), Child Helpline International, ECPAT International, Plan International, Save the Children, SOS Children's Villages International, Terre des Hommes (Tdh), UNICEF, UNODC, and UNFPA; South Asia Initiative to End Violence against Children (SAIEVAC) as a Special Member; and Associated agencies - Centre for Reproductive Rights, Planète Enfants, and UNESCO.

#### **Objectives of the SACG Meeting**

• To discuss and identify SACG support to strengthening and consolidation of the national mechanisms to facilitate achievement of the SAIEVAC-NACG-SACG targets – in line with the

outcomes of the consultations at the 4<sup>th</sup> NACG meeting and in view of the SACG Priorities and workplan for 2014; and adjust the workplan accordingly.

- Review with SRS and agree on the technical, financial and organizational support to the SAIEVAC Technical Consultation on Children with Disabilities; establish the SACG Advisory Committee for the Technical Consultation.
- Review progress along the four priority areas and update the 2014 SACG workplan;
- Information sharing by the SACG members;
- SACG Technical Working Groups: updates, membership and planned action;
- Discussion on Chair and Co-Chair for 2015-16.
- Any other business

#### **Expected Outputs**

- Updated SACG Workplan, including members' commitments, for 2014.
- Updated Plan of SACG Support to the 4<sup>th</sup> Technical Consultation and its in-country preparatory processes, with a focus on NACG and child participation.
- Updated status of member agencies and SACG Technical Working Groups
