# Appointment of a replacement member to the Independent Oversight Advisory Committee (IOAC)

#### Purpose of the document

In this paper the Governing Body is invited to appoint a replacement member to the Independent Oversight Advisory Committee following the resignation of one of the current members.

- **1.** At its 316th Session (November 2012), the Governing Body approved revised terms of reference for the Independent Oversight Advisory Committee (IOAC) <sup>1</sup> and appointed five members for a term of three years. <sup>2</sup>
- **2.** The members appointed were:
  - Mr Denys Chamay (Switzerland)
  - Mr Luis Guillermo Chinchilla (Peru)
  - Ms Bushra Naz Malik (Pakistan)
  - Ms Hilary Wild (United Kingdom)
  - Ms Jeya Wilson (South Africa)

#### Reserve list:

- Ms Eileen Fusco (United States)
- Mr N.R. Rayalu (India)
- **3.** Due to health reasons, Mr Chamay has tendered his resignation from the Committee. In accordance with the approved terms of reference, the Governing Body is requested to appoint a replacement for Mr Chamay selected from the reserve list to serve the remainder of his term, that is, until 31 December 2015.
- **4.** Informal consultations have taken place with regional coordinators, representatives of the Workers' and Employers' groups and of the Chairperson of the Government group. At the date of preparing this document, consensus had not been found on the preferred candidate.

### **Draft decision**

- 5. The Governing Body:
  - (a) appoints XXXXXXX as a member of the IOAC for a term commencing immediately and expiring on 31 December 2015; and
  - (b) requests the Director-General to convey its appreciation to Mr Chamay for the services he has rendered as a member and past Chairperson of the IOAC.
