*President: Ms Oliphant***RECORD VOTE ON THE AMENDMENTS OF 2016 TO THE CODE RELATING TO REGULATION 4.3 OF THE MARITIME LABOUR CONVENTION, 2006****The PRESIDENT**

I now open the twelfth plenary sitting of the Conference.

We shall continue our work immediately with the announcement of the results of the vote on the maritime amendments, before taking up the consideration and adoption of the report of the Committee for the Social Justice Declaration.

The results of the vote on the maritime amendments, held yesterday morning, are as follows.

In respect of the record vote on the amendments to the Code relating to Regulation 4.3 of the Maritime Labour Convention, 2006 (MLC, 2006), the quorum was fixed at 308 and the required two-thirds majority was 261. The votes were cast as follows: 388 votes in favour, two against, with 15 abstentions.

The Conference, therefore, approves the amendments.

**RECORD VOTE ON THE AMENDMENTS OF 2016 TO THE CODE RELATING TO REGULATION 5.1 OF THE MARITIME LABOUR CONVENTION, 2006****The PRESIDENT**

In respect of the record vote on the amendments to the Code relating to Regulation 5.1 of the MLC, 2006, the quorum was again set at 308 and the required two-thirds majority was 261.

The result of the vote is as follows: 389 votes in favour, two against, with 14 abstentions.

The Conference therefore approves the amendments.

**RECORD VOTE ON THE AMENDMENTS OF 2016 TO THE ANNEXES OF THE SEAFARERS' IDENTITY DOCUMENTS CONVENTION (REVISED), 2003****The PRESIDENT**

Turning now to the record vote on the amendments to the annexes of the Seafarers' Identity Documents (Revised) Convention, 2003 (No. 185), I would remind the Conference that the requirements set out in Article 8(1) of the Convention stipulate that, subject

to the various provisions of the Convention, amendments to the annexes may be made by the International Labour Conference, acting on the advice of a duly constituted tripartite maritime body of the ILO. The decision shall require a majority of two-thirds of the votes cast by the delegates present at the Conference, including at least half of the 32 member States which have ratified this Convention so far.

The quorum was again set at 308, the majority at 252 and the requirement of the double majority of half the member States that have ratified Convention No. 185 was 16.

The result of the vote is as follows: 374 votes in favour, including 21 ratifying member States; three votes against; and 28 abstentions.

The Conference therefore adopts the amendments to the annexes of Convention No. 185.

*Original Spanish: Ms SÁNCHEZ BELLO (Government, Bolivarian Republic of Venezuela)*

The Government of the Bolivarian Republic of Venezuela would like to explain its abstention with regard to the amendments to the Code of the MLC, 2006. We recall that in 2006, our Government abstained with regard to the MLC, 2006, because in the Preamble to the Convention reference is made to the United Nations Convention on the Law of the Sea, which does not apply to the Bolivarian Republic of Venezuela because it is not a party to that legal instrument and, indeed, voted against it when it was adopted.

Consequently, the Government of the Bolivarian Republic of Venezuela is maintaining a position consistent with the legal position expressed back in 2006. Once again, we have abstained because the amendments are part and parcel of the MLC, 2006.

Nonetheless, our Government does recognize that the MLC, 2006, aims to strengthen the labour rights of seafarers. Seafarers are recognized in our legislation, which supports and guarantees broad-ranging rights which are protected and elaborated in articles 245–267 of our basic labour law, covering the workers of Venezuela.

Moreover, our Government is maintaining a position consistent with its position in 2003, in the framework of the 91st Session of the International Labour Conference, with respect to Convention No. 185, as you can see in *Provisional Record* No. 27 of that sitting. The Government of the Bolivarian Republic of Venezuela also abstained on that occasion with regard to the amendments to the annexes of the Seafarers' Identity Documents Convention, 2003 (No. 185).

Ms LIEW (*Worker, Singapore*)

Speaking as the Workers' delegate and deputy member of the ILO Governing Body, as well as President of the Singapore National Trades Union Congress and General Secretary of the Singapore Maritime Officers' Union, I am delighted to hear the strong mandate for the approval of the amendments to the Code of the MLC, 2006, and the adoption of the amendments to the annexes of the Seafarers' Identity Documents Convention (Revised), 2003 (No. 185).

Ninety per cent of world trade is carried out by sea. Our daily necessities – gas, fuel, cars, clothing, medication; the list is long – are mainly transported by seafarers all over the world. Seafarers are an important part of the global supply chain. So we are extremely pleased that, at this Conference, there has been much discussion in the global supply chains agenda. We are looking forward to hearing positive

outcomes and seeing the report of the Committee on decent work in global supply chains.

Our seafarers work on board ships away from home for some six months at a time. There is no escape for them. If bullying and harassment issues are not addressed, situations can become very serious, with serious consequences and can impact seafarers' physical and mental health. We are pleased that the maritime amendments that have been adopted help to eliminate shipboard bullying and harassment. Now our seafarers can have peace of mind and stay safe and healthy in their workplace.

The amendments also address the issue of gender-based violence. This is a timely development in view of the upcoming standard-setting item on violence against women and men in the world of work. We now have some 75 ratifications of the MLC, 2006, which shows its relevance for the shipping industry; it now covers over 90 per cent of the world fleet, in terms of gross tonnage. This is indeed a significant achievement. One hundred per cent coverage of the world gross tonnage of ships is now within our reach. The MLC, 2006 is an excellent marker for what the ILO can achieve in other areas. So, on behalf of our Workers' group and some 1.5 million seafarers all over the world, we thank the ILO and the tripartite delegates for their strong and ardent support.
