

Composition

- **6.** Further to the decision ² adopted by the Governing Body at its 326th Session (March 2016), the Working Group will be composed of four Government representatives, four Shipowner representatives and four Seafarer representatives. The Working Group will be chaired by the Chairperson of the Special Tripartite Committee.
- **7.** Further to consultations with the Regional Coordinators, the Director-General intends, in order to obtain the Government nominations, to approach the Governments of the following countries: Canada, France, Nigeria and the Philippines.

Career highlights of the four members of the Committee of Experts on the Application of Conventions and Recommendations considered for reappointment

Mr Mario Ackerman (Argentina)

Professor Mario Ackerman has been a member of the Committee of Experts on the Application of Conventions and Recommendations since 2005, with special responsibility for the freedom of association, collective bargaining, and industrial relations Conventions. He is fluent in the three working languages and has participated actively, in light of the ILO Declaration on Social Justice for a Fair Globalization, 2008, in four working groups on the General Surveys on the fundamental Conventions concerning rights at work, on labour relations and collective bargaining in the public service, and on migrant workers. Professor Ackerman has participated actively in high-level promotional activities related to international labour standards with excellent results. His expertise is highly valued by the Committee.

Professor Ackerman is a Professor of Labour Law, Director of the Masters and Specialist Postgraduate Labour Law Studies at the Faculty of Law of the University of Buenos Aires. He is the Director of the *Revista de Derecho Laboral*.

Professor Ackerman is a former adviser to the Parliament of the Republic of Argentina and former National Director of the labour inspectorate of the Ministry of Labour and Social Security of the Republic of Argentina.

Ms Leila Azouri (Lebanon)

Professor Leila Azouri has been a member of the Committee of Experts on the Application of Conventions and Recommendations since 2014, with special responsibility for the occupational safety and health Conventions. She will participate in the Working Group on the General Survey concerning occupational safety and health instruments that will take place in November 2016. The quality of her work is highly appreciated by the Committee.

Professor Azouri is a Professor of Labour Law at the Faculty of Law at Sagesse University, Beirut. She is Director of Research at the Doctoral School of Law of the Lebanese University and former Director of the Faculty of Law of the Lebanese University.

Professor Azouri is member of the Executive Bureau of the National Commission for Lebanese Women and a legal expert for the Arab Women Organization.

Ms Graciela Josefina Dixon Caton (Panama)

Ms Graciela Josefina Dixon Caton has been a member of the Committee of Experts on the Application of Conventions and Recommendations since 2010, where she has dealt in particular with the fishers' and seafarers' Conventions, including the Maritime Labour Convention, 2006 (MLC, 2006). She has participated actively in the Working Group on the General Survey concerning minimum wage fixing instruments that took place in November 2013. She has also actively participated to the work of the 2015 Subcommittee for the streamlining of treatment of certain information, which was established by the Committee in 2012 with a particular focus on information related to reporting obligations. The quality of her work is highly appreciated by the Committee.

Ms Dixon Caton is a graduate of law and political science at the University of Panama and followed postgraduate studies in human rights. She is a former President of the Supreme Court of Justice of Panama and a former President of the Penal Court of Cassation and of the Chamber of General Business Matters of the Supreme Court of Panama. She is a former President of the International Association of Women Judges. She is presently Arbitrator at the Court of Arbitration of the Official Chamber of Commerce of Madrid, and Arbitrator at the Centre for Dispute Resolution (CESCON) of the Panamanian Chamber of Commerce.

Mr Raymond Ranjeva (Madagascar)

Judge Raymond Ranjeva has been a member of the Committee of Experts on the Application of Conventions and Recommendations since 2008, and has had special responsibility for examining the application of the Forced Labour Convention, 1930 (No. 29). He greatly contributes to the work of the Committee by bringing his international experience as a former Judge of the International Court of Justice. Judge Ranjeva was Chairperson of the Commission of Inquiry to examine the observance by the Government of Zimbabwe on Conventions Nos 87 and 98.

Judge Ranjeva is a Doctor of Law of the University of Paris II and *Agrégé* of the Faculties of Law and Economics, Public Law and Political Science section, Paris. Former Vice-President of the International Court of Justice, Judge Ranjeva is a member of the Court of Arbitration of the International Chamber of Commerce, a member of the Court of Arbitration for Sport and a member of the Institute of International Law. He is President of the African Society of International Law since 2012.

Judge Ranjeva is a member of numerous national and international professional and academic societies, Curatorium of the Hague Academy of International Law and a member of the Pontifical Council for Justice and Peace.
