Workers' delegates and advisers participate in the work of the technical committees of the Conference as **regular members** or as **deputy members** (deputy members can take part in a vote only to replace regular members who are absent at the time of voting).

Workers' delegates are kindly requested to fill out the enclosed form to indicate membership of the various committees of the Conference and return to actrav-conf@ilo.org by **21 May 2018**.

Please tick either the *Titular* or *Deputy* box and add the names of the Worker members of the delegation who will be following the work of each committee.

Remember that a *Titular member* needs to be at the committee for every sitting (including night and weekend sittings) and can be Titular in one committee only.

The Workers' group – following the indications of the ILO Constitution (art. 3.2) – has requested national delegations to ensure gender balance, having one woman or more in the delegation as per the target set by the United Nations of increasing the participation of women in decision and policy-making bodies (to at least *50 per cent*). Many Workers' delegations are below the threshold and every effort should be made to redress this situation.

In the case of *standard-setting discussions* over two years (as is the case this year with the first reading of the item on violence and harassment in the world of work, which will continue in 2019), trade unions should strive to ensure that the same person covers the two sessions of the Conference.

Please note that **committee membership** as indicated in the form **will be effective only** once:

- the Office has received official credentials from the government accrediting the persons concerned as Workers' delegate, adviser or person designated in accordance with article 2(3)(i) of the Standing Orders of the Conference; and
- the registration request is endorsed by the Workers' group and the initial committee composition approved by the Conference.
