## Appointment to the ILO Staff Pension Committee (United Nations Joint Staff Pension Board)

1. In accordance with article 6(c) of the Regulations of the United Nations Joint Staff Pension Fund (UNJSPF), three members and three alternate members are appointed to the ILO Staff Pension Committee (United Nations Joint Staff Pension Board) by the International Labour Conference on the recommendation of the Governing Body. The Governing Body decided at its 253rd Session (May–June 1992) that appointments to the Staff Pension Committee should reflect tripartite representation.
2. The appointments for a period ending on 8 October 2022 are placed before the current session of the Governing Body for recommendation to the 109th Session (June 2021) of the International Labour Conference.
3. The terms of the following Staff Pension Committee members and alternate members exceptionally appointed by the Governing Body pending confirmation by the Conference <sup>1</sup> either expire on 30 June 2021 or need to be confirmed:

4. The Government group proposes the nomination of Mr Juan Carlos Pomareda Muñoz as member for the period from 1 July 2021 to 8 October 2022. Mr Pomareda Muñoz is Second Secretary at the Permanent Mission of Peru to the United Nations and other international organizations in Geneva.
5. The Employers' group proposes the confirmation of Mr Merle's appointment as member for the period ending on 8 October 2022, and has suggested the appointment of Mr Abbé-Decarroux as alternate member for the same term. Mr Abbé-Decarroux has previously served as the titular member of the Employers' group and is currently Deputy Director-General of the Fédération des Entreprises Romandes.
6. The Workers' group proposes the nomination of Mr Luca Cirigliano as member and Mr Corrado Pardini as alternate member for the period from 1 July 2021 to 8 October 2022. Mr Cirigliano is the Secretary-General of the Swiss Federation of Trade Unions and Mr Pardini is the Political Advisor of the Swiss Syndicat UNIA.
