► Information for delegates registered in the General Affairs Committee

Tentative plan of work

- Two items are referred to the General Affairs Committee:
 - (i) the inclusion of safe and healthy working conditions in the ILO's framework of fundamental principles and rights at work through an amendment to paragraph 2 of the ILO Declaration on Fundamental Principles and Rights at Work, 1998; and
 - (ii) the approval of amendments to the Code of the Maritime Labour Convention, 2006 subject to the adoption of any amendments by the Special Tripartite Committee of the Maritime Labour Convention, 2006 at the second part of its fourth meeting in May 2022.
- As per the Committee's mandate, additional items could be sent to the General Affairs Committee by the Conference, for instance an urgent draft resolution (Article 18(8) of the Standing Orders of the Conference). For this reason, the Committee may need to be reconvened following the discussion of the two items listed at 1 above.
- With respect to the second item, the Workers' and Employers' groups, as well as any
 government delegate will have an opportunity to make statements or observations in
 accordance with the speaking time limits set out in point 5 below. These statements or
 observations will be in respect of the eight amendments adopted by the Special
 Tripartite Committee, and report ILC.110/D.2.
- With respect to the first item, a draft resolution has been prepared by the Office to serve
 as a basis for discussions, following Governing Body discussions and informal tripartite
 consultations. This text is based on consensus built up through several rounds of
 preliminary consultations with the constituents. Delegates are strongly advised to limit
 any possible amendments to address the last four pending issues:
 - the determination of occupational safety and health as a 'shared responsibility' (draft fourth preambular paragraph)
 - the formulation of the new fundamental principle and right at work (draft operative paragraph 1),
 - the identification of fundamental conventions (draft operative paragraph 3)
 - and the wording of the saving clause (draft operative paragraph 5).
- The tentative plan of work for the General Affairs Committee has been posted on the Committee's web page. This will be proposed for adoption during the Committee's first sitting.
- The Daily Bulletin, as well as the ILO Events Application, will include announcements of Committee's sittings, any changes to the schedule, and information on the submission of amendments.

Registration in the Committee

- Although the composition of the General Affairs Committee mirrors that of the Governing Body, any accredited delegate and adviser, including government representatives, who wishes to participate in committees may do so. They do however need to register individually to receive their individual links to the Committee meetings.
- Registration of Government, Employers' and Workers' delegates and advisers in committees will be undertaken by each group as per usual practice.
- Committee membership will be effective only once the Office has received official credentials in respect of the Government, or the Employer or Worker delegate or adviser concerned.
- Please note that changes in the composition of committees registered with the relevant group secretariat by 17:00 become effective the following working day of the Conference.
- In accordance with article 36(4) of the Standing Orders, in addition to the members of a committee, any delegate, or any duly authorized adviser, is entitled to participate with the same rights as the members of the committee except the right to vote.
- In accordance with the Standing Orders of the Conference, article 7, para 1, only the 56 titular members of the Governing Body, or any substitute designated to that effect, may vote in the General Affairs Committee. All voting will be by electronic means. As the composition of the General Affairs Committee mirrors that of the Governing Body, there is no weighing of votes (2-1-1).

- During the discussion of amendments, the floor may be requested by either raising a nameplate, a virtual hand or through the chat.
- Should you wish to raise a point of order or request the right of reply in the Committee, please do so through either by raising a nameplate or through the chat function, indicating whether it is a point of order or a request for the right of reply. In the latter case, please also indicate the intervention in respect of which the right of reply is sought.

Statements made on behalf of groups of governments

- All statements made by Government members on behalf of all governments, a regional group or members of an intergovernmental organization, unless otherwise specified, will be reported as having been made on behalf of all Governments members of the group or organization in question who are members of the ILO and are attending the Conference.
- When speaking on behalf of only a few members of such a group, please indicate this clearly both on the form and when taking the floor.

Time limits for speeches during the general discussion segment, 30th and 31st May, 2022

- The Officers of the Committee suggest differentiated speaking time limits, as follows:
 - Opening statements and general discussion
 - o Vice-Chairpersons: 12 minutes for initial;
 - Spokesperson on behalf of Government Group: 12 minutes;
 - o Members speaking on behalf of regional groups and on behalf of several Committee members: **5 minutes**:
 - o Individual Committee members: **3 minutes**; and
 - o Spokespersons of international organizations (IGOs): **3 minutes**.
 - Subject to approval of the Chairperson and Vice Chairpersons, and time permitting, a maximum of **3 minutes** will be given to each INGO to address the Committee immediately following the General discussion.

As has been general practice, the Reporter is usually from the Government group. The Reporter may also participate in the Conference Drafting Committee.

Decision-making and votes in the Committee

• In accordance with the Standing Orders of the Conference, article 7, para 1, only the 56 titular members of the Governing Body, or any substitute designated to that effect, may vote in the General affairs Committee. All voting will be by electronic means. As the composition of the General Affairs Committee mirrors that of the Governing Body, there is no weighing of votes (2-1-1).
