The HIV and AIDS Recommendation No. 200 has been translated into 30 languages.

Recommendation No. 200 has been cited, in conjunction with Convention No. 111 in **at least eight national and regional court cases** upholding the rights of HIV-positive workers involving unfair dismissal.

More than 50 countries have developed national workplace policies and sectoral policies, and legislation based on the principles of Recommendation No. 200.




